## **RENTAL APPLICATION REQUIREMENTS**

This is a list of items and information needed in order to process your application in a timely manner:

1. VALID California Driver's License or California Identification card for each applicant eighteen (18) years of age and older.
2. Social Security Card for each applicant eighteen (18) years of age or older.
3. Several paycheck stubs including a most current paycheck stub (at least 3 originals). If there are two or more applicants, we will need several paycheck stubs including the most current paycheck stub from each adult person who is presently employed. If you are self-employed, we will need a copy of your most current tax return or other proof of income. Verifiable employment and income being 2x the rent amount.
4. An "Application to Rent" **MUST be completely filled out by all applicants eighteen (18) years of age and older (Even if they are not employed)**. Please make sure that the application is filled out **COMPLETELY**, including all phone numbers, cities, and zip codes so that there will be no delay in processing of your application.
5. All applicants **MUST** submit a **\$100.00 good faith deposit** and pay a screening fee of \$49.00 per individual eighteen (18) years of age and older. All screening fees and good faith deposits **MUST** be paid by **MONEY ORDER** or **CASHIER'S CHECK "only"** (No Cash). The screening fee is entirely **NON-REFUNDABLE**. You must submit **2 SEPARATE** Payments, 1 for the credit check fee and 1 for the good faith deposit. Good Faith deposit is refundable on application being denied, if application is approved good faith deposit is non-refundable.
6. **Minimum of 650 Fico** is required along no utilities in collections or money judgments.
7. Upon approval of your application, an additional deposit may be required to hold the unit.
